JOB TITLE: Children's Ministry Director

#### JOB OVERVEW:

The Children's Ministry Director (CMD) is responsible to provide leadership, development and oversight to all Children's Ministry initiatives under the umbrella of Riverwood Kids. This individual will create dynamic environments for spiritual learning and life change for children in grade 5 and under. It will be the task of the CMD to develop the Riverwood Kids curriculum with the goal to help each child grow and be rooted in the following core biblical principles: L1 - Living Intimate with God, L2 - Living in Deep Community and L3 - Living Lives of Influence.

### TIME REQUIREMENTS:

General office hours are 9:00am to 5:00pm, Tuesday to Friday. Must also be available for weekend worship services. A flexible weekly schedule, including hours worked remotely, can be requested and developed in agreement with the immediate supervisor.

- Ensure the ongoing development and implementation of a written strategic plan and goal process (minimum 3 years) that is in alignment with Riverwood's goals, mission, and values.
- Dedicate time to personal spiritual development.
